**Best Shot** - Two players throw and then proceed together from the more advantageous lie.

**Random Draw** - Chips will be drawn by all registered players to determine teammates and starting positions.

**Mulligan Rule** - When playing doubles the possibility of an odd number of players may occur within your division. In this event a Mulligan Rule will apply to the player drawing the odd chip. See official rules for details.

**Women and Juniors Handicap Rule** - One favorable tee and/or a two-stroke advantage. See official rules for details.

**Points Purse** - A seasonal point's purse will be administered and will count your best eighteen of twenty-four possible finishes. Thus, allowing six scratches.

**When** - Every Wednesday beginning April 9th, 2008 and concluding September 17<sup>th</sup>, 2008.

**Plus\*\*\*** The 19<sup>th</sup> Annual NRDG End of Year Tournament to be held at Como Park on Saturday September 20<sup>th</sup>, 2008.

**Where** - Location will vary but follow the same rotation for the first 18 weeks. The rotation reverses for the last 6 weeks.
